### Why Inspectors Should Take Continuing Education, Even When It's Not Required

Some states require home inspectors to meet minimum Continuing Education requirements each year. However, even if your state or province does not, there are still good reasons for taking such courses regularly.

1. First and most obviously is the fact that taking courses can help you become a better inspector. Smart inspectors who are serious about their business will stay on top of their game by continually

learning. Furthermore, the growing innovations in the building industry mean that there's always something new for the inspector to know.

2. An inspector who keeps current with the industry will almost always have greater credibility


with consumers. Taking Continuing Education courses strengthens an inspector's credentials, and the inspector's credentials are important in marketing his services. Many InterNACHI members now display their Certificates of Completion on their websites. Inspectors who have taken any of InterNACHI's courses can download and print off multiple copies of their Certificates of Completion.

3. An inspector who has completed many Continuing Education courses provides a measure of protection for the real estate agent who referred the inspector. Often, when an inspector gets sued, the agent also gets sued for a negligent referral. It is difficult to succeed in such a claim if the inspector is able to produce a long list of robust courses that s/he has completed.

4. Attending or taking online Continuing Education classes can strengthen an inspector's credibility in court. In states where Continuing Education classes are manda-

> tory, an inspector's failure to meet the state's requirements could



sidered evidence of negligence in a civil suit against the inspector. Even in states and provinces that have no mandatory education requirements, an inspector's failure to keep current in the field will diminish the inspector's credibility if he ever testifies in

court or at a deposition. A judge or jury is far more likely to find an inspector's testimony persuasive if the inspector regularly takes Continuing Education classes.

5. Finally, like it or not, inspectors must sometimes testify as experts. Failure to keep current in the field could result in a ruling that disqualifies the inspector as an expert altogether. An interesting case that illustrates this point is Pettit v. Hampton and Beech, Inc., 922 A.2d 300 (Conn. App. 2007). In this case, the plaintiffs asked the court to disallow an inspector's testimony because they alleged he was not qualified to give an expert opinion on the cost of repairs. The court overruled the plaintiff's objection and qualified the inspector as an expert, in part, because of his Continuing Education activities. In another case, GSB Contractors, Inc. v. Hess, 179 S.W.3d 535 (Tenn. App. 2005), the court qualified the inspector as an expert, in part, because of his Continuing Education and teaching background.

To sum up, there are many good reasons for inspectors to take Continuing Education courses. InterNACHI's online inspection courses are approved, accredited and free. So, inspectors really have no excuse for failing to avail themselves of InterNACHI's educational offerings.

### EPA Lead-Safe Certified RRP Course for Contractors and Inspectors

his course was developed to train inspectors and contractors how to work safely in housing with lead-based paint and comply with the EPA's Renovation, Repair and Painting (RRP) Rule and HUD's Lead-Safe Housing Rule.

Federal law requires renovation firms (including sole proprietorships) to be certified and requires individuals to be trained in the use of lead-safe work practices. To become certified, renovation contractors must submit an application and fee payment to the EPA or to the state if you work in one of the states authorized to run their own RRP pro-



grams. Individuals wishing to become certified renovators must take training from an EPA-accredited training provider.

In addition, renovation firms must be certified by the EPA or by a state authorized by the EPA to administer its own program. Firm certification is easy. Firms need to send in a two-page application to the EPA and pay a fee of \$300. EPA certification is good for five years.

Federal law mandates that all contractors and maintenance workers (from plumbers to electricians to painters to handymen) performing renovation, repair and painting projects that disturb lead-based paint in any pre-1978 homes, buildings, child care facilities and schools be certified by the EPA. Firms are required to use Lead-Safe Certified Renovators who are trained by the EPA-approved training providers to follow lead-safe work practices.

#### To become Lead-Safe Certified:

- 1. Submit an application and fee payment to the EPA.
- 2. Take eight hours of training from an EPA-approved training provider, such as InterNACHI. InterNACHI's course is EPA approved.

#### Do the following 3 steps:

- Complete the six-hour online portion of this course. InterNACHI membership is required. Purchase the course and receive a student membership free.

nline and video courses are perfect for educating and improving the competence of home inspectors and providing options for their primary and Continuing Education. Advantages over classroom courses include:

**Cost of Course:** Online courses are inexpensive or free. Dollar for dollar, an inspector can complete many online courses for the same cost as a single classroom course. Compared to online courses, classroom courses exhaust the Continuing Education budgets of inspectors faster than online courses.

**Cost of Travel:** There are no travel or hotel costs associated with online courses.

**Cost of Lost Work:** An inspector need not take off work to complete online courses. Online courses can be taken at night, on the weekends, or whenever an inspector doesn't have any inspections scheduled. In contrast, classroom courses are often offered only during the day and require the inspector to suffer lost business income.

Cost Advantage to Consumers: Online inspec-

tion courses are simply more affordable for inspectors. With reduced course costs come an increase in the number of courses an inspector can afford to complete each year, with a corresponding rise in the level of inspector competence. Increasing the level of inspector competence is a direct benefit to consumers. Lower-cost education also gives inspectors the opportunity to pass on savings to consumers.

**Accessibility:** Online courses are available all the time, anytime, from anywhere. In contrast, classroom courses for the inspection industry are few and far between. Compared to online courses, classroom courses limit access to education for inspectors.

**Collaboration in Development:** Online course development often includes collaboration among many experts and inspectors from around the world. For example, it is not unusual for InterNA-CHI's online courses to be the product of dozens of contributors.

**Expert Instruction:** Online course developers can hire many experts to contribute to each course. Often, in online video courses, the instruction is presented by one or more renowned experts. In contrast, classroom instructors, though perhaps competent to teach a particular subject, are rarely international experts.

**Number of Instructors:** Online courses often utilize more than one instructor, with more than one area of expertise. In contrast, most classroom courses are taught by only one instructor.

**Accuracy:** Online courses are reviewed for accuracy before being released. Online courses are also subjected to industry-wide peer review forever. In contrast, course curriculum is rarely reviewed, once established.

**Current Course Material:** Downloadable, printable online course material is reviewed, edited and improved over time. In contrast, classroom texts are less frequently updated.

**Pictures and Video:** Online courses contain pictures and on-location video that permit the inspector to virtually accompany the instructors on inspections of many actual structures and components. In contrast, classroom courses can't take inspectors into crawlspaces or on roofs.

**Pace:** Online courses move at each inspector's desired pace. Online courses can be stopped and re-started. Online video can be paused. In contrast, classroom courses move at only the instructor's speed, or, worse, at the speed of the slowest student in the classroom.

**Wasted Time:** Classroom courses require setup time, off-topic discussions, bathroom breaks, lunchtime, etc. Online courses contain no such wasted time.

Why Online Courses are
Superior to
Classroom Courses

**Schedule:** Classroom courses have inflexible schedules that

require inspectors to attend when it is inconvenient, when the inspector is ill, when the inspector is tired, etc. Online courses are available when each inspector wants to take them.

**Quizzes and Exams:** Online courses contain numerous short quizzes that assure the inspector has learned each section before moving on to the next. These quizzes are graded instantly, and often alert the inspector to incorrect answers immediately. Some even have built-in intelligence, which recognizes each inspector's unique areas of weakness, and reviews those areas until the inspector grasps them. Classroom courses typically have fewer quizzes, without instant grading.

**Review:** Online courses permit inspectors to go back and review areas of weakness. For example, InterNACHI's online video courses available exclusively on NACHI.TV permit the inspector to rewind and replay them over and over. In contrast, classroom material is typically covered only once.

**Repeat:** Online courses permit inspectors to take the course over again. In contrast, class-

room courses are typically taken only once.

**Instant Grading:** Online courses contain quizzes and final exams that are graded instantly. Instant grading permits the inspector to be alerted to areas of weakness while still begin engaged in the course. In contrast, classroom courses typically don't grade instantly.

**Advanced and Specialty Courses:** It is financially feasible to offer advanced and specialty courses online. An online course is developed only once, yet can run for years. In contrast, classroom courses usually must be of an introductory nature to attract enough students to pay for an instructor each time it is offered.

**Choice:** Online courses offer inspectors a wide variety of choices in both level and subject matter. In contrast, classroom courses are fewer and farther between.

**Communication:** Online courses often provide an Internet forum for all current students, graduates, instructors, experts, developers and interested parties from around the world to interact with each other and discuss the course. These course-specific forums provide continuing education to inspectors long after completing the course. Classroom courses rarely provide such widespread, post-course interaction.

Home inspection licensing board members or government bureaucrats who steer inspectors away from online courses by rejecting their Continuing Education approval based solely on their method of Internet delivery create a disincentive to inspector skill-set improvement, which ultimately harms consumers. And because much of an inspection report includes safety issues, the harm may also be physical, instead of merely financial. In some cases, the harm may result in the actual death of either the inspector or the consumer.

In summary, online courses allow inspectors to study and learn at little or no cost, without having to travel or lose business, when and where they want, with well-developed, accurate courses taught by experts, using updated course material, pictures and video, at their own pace and schedule, with the ability to review and repeat, and with the assurance they'll end up with a thorough understanding of the chosen topic.



### **How to Inspect for Moisture Intrusion**
